Please carefully read the policies below. Your signature below acknowledges that you have read and understand the policies. Neu Wixom Dance Academy reserves the right to amend the wavier form.

**Child's Safety & Dress Code:** I understand that I am responsible for my children's behavior and safety while on the Neu Wixom Dance Academy premises, including parking lots, bathrooms, waiting areas, lounge area, etc. I am also responsible for my children's behavior during class. I understand that if my children do not follow the instructors' directions, then they may have to sit out or be removed from class at the instructors' discretion. A dress code shows an elevated level of professionalism and structure. Uniformity helps students to focus on their dance training rather than on their clothing. Technical corrections and viewing body alignment can only be made with a dress code. Proper dance shoes and attire are also essential to the learning process and to avoid injury. Jewelry, gum, food, and colored liquids are not allowed (post earrings and water are acceptable in the studios). Hair must be pulled back off of the face and neck for all classes including Hip Hop and Breakdance.

**Tuition: Non-recital** - I understand that this type of tuition is due, in full, by the first class of the session.

**Recital Classes (school year)**- I understand that this type of tuition is a total amount that is broken down into 10 payments from September to June. You may pay the full tuition at registration or choose to pay each month for ten months. I understand that "June" tuition helps cover the cost of my children's participation in the dress rehearsal and recital. There is no separate "recital fee." If paying monthly, **the tuition is due by the 1<sup>st</sup> class of each month.** Invoices will not be sent, but reminders will be emailed a week before tuition is due. Reminder signs will also be posted on the outside doors to the academy. **I UNDERSTAND THAT ANY PAYMENT MADE AFTER THE 1<sup>st</sup> CLASS OF EACH MONTH WILL BE CONSIDERED LATE AND, THEREFORE, I WILL INCUR A \$15.00 LATE FEE. The late fee may be waived if two months are paid at the same time.**

**\*Students will not be able to take classes if accounts are past due.\***

**Annual Family Registration Fee:** A \$25 one-time registration fee is payable once a year from the month of enrollment; this fee is good for the entire household.

**No refund policy:** **No refunds will be made after the first class, camps, etc. regardless if the student has attended the class or not. A credit may be given in cases of an illness or injury.** A one-time \$5.00 trial class may be taken before committing to a class. Refunds before the first class will be charged a \$10.00 processing fee. \$15.00 will be charged for all returned non-sufficient fund checks.

**Photographs and Videos:** I give permission to allow Neu Wixom Dance Academy to post pictures and/or videos of my child(ren) at dance for use on the website, Facebook, in brochures and the like.

**Missed Classes:** **No credit is ever given for missed classes.** Missed classes can be made up on a space available basis. All make-up classes must be scheduled at the front desk. Make up classes must be made up within 2 months of the missed class(es). In the case of poor recital class attendance, 1 or more private lessons must be scheduled with the student's teacher to make-up for missed recital choreography (cost for private lessons are based on the individual teacher).

**Canceled Classes & Holiday Closings:** Neu Wixom Dance Academy reserves the right to change or cancel any class due to low enrollment. If the weather forces us to close, a message will indicate this on the academy's voice mail. Students may make up the missed class(es) due to bad weather. The academy will close with the Walled Lake Consolidated School District for certain holidays. Check with the front desk for a schedule of these closings (closings are already figured into total recital tuition for the school year).

**Additional costs for recital classes:** Additional costs include the recital costume(s) deposit(s) (\$50 non-refundable deposit per costume) and balance, which must be paid before costumes ship. Once costumes are ordered, all costume balances must be paid regardless if a student drops the class. New dance shoes may have to be purchased before recital due to foot growth &/or for class uniformity on stage. Costume pictures (optional) and recital tickets are extra. (See Company Contract regarding extra costs for company members.)

**Recital Commitment Signature:** By signing below, my children and I understand that joining a recital class means a ten month dance season commitment from September to June. My children are required to attend class each week, schedule and attend make-up classes (or private lessons for poor attendance) if regular class is missed, participate in the costume pictures (even if not ordering pictures) and attend the Dress Rehearsal and Recital. Frequent absences and/or tardiness may result in the dismissal of your children from their recital classes.
